CORE COMPONENTS OF REGISTERED APPRENTICESHIP

Registered Apprenticeship (RA) is the most time-proven, successful model of work-based learning for individuals as young as 16. By creating RA pathways with your local employer partners, your Academy can provide students with:

- > Paid employment RA is a paid job from day one; students can work parttime while completing their related instruction (RI) classes and then finish their paid On-the-Job Learning (OJL) after graduation/completion.
- Mentored OJL all apprentices are teamed with an experienced mentor to build their technical and professional workplace skills from day one.
- High-Value Related Instruction your Cisco Networking Academy classes can count toward high school graduation, college degree or academic certificates AND the RI requirement for their RA program.
- Wage increases all apprentices can earn wage increases during their RA program for demonstrating measurable skill gains.
- A national occupational credential upon completion of the program.

CISCO'S APPRENTICESHIP GUIDELINES

Cisco has National Guideline Standards (NGS) approved by the U.S. Department of Labor (DOL) for three occupations:

-) IT Generalist
- > Cybersecurity Support Technician
- > Network Technician

APPRENTICESHIP ROLES

Cisco Networking Academies can play one or more of the following RA roles:

- Sponsor* An organization that agrees to operate an apprenticeship program and in whose name the program is registered.
- RI Provider Entity that provides instruction to apprentices in the designated occupation's core knowledge, skills, and abilities. For all Cisco NGS-based RA programs, academies will serve as the RI provider.
- **Employer** Hires and provides paid OJL for apprentices under supervision of a designated mentor who is a skilled professional in that occupation.
- Partner Organizations committed to assisting RA programs in practical ways such as program outreach, supportive services, etc.

^{*}Host institutions of Cisco Networking Academies may already be approved as an RA program sponsor.

All that is required is to simply add the Cisco occupation(s) to the organization's current RA program standards. Safal Partners can work with your state's DOL Office of Apprenticeship or State Apprenticeship Agency (SAA) to have your program expanded quickly, in some cases within a few weeks.
